### **EMVO: Updating Product Master Data (PMD) for All Target Markets**

EMVO has identified instances where Product Master Data (PMD) is not being correctly updated to reflect new target markets—such as Greece.

All intended markets for your product(s) must be included in the Product Master Data (PMD) uploaded to the EU Hub. This is essential to ensure that the associated batch data can be correctly transmitted to the relevant national

If you are adding a new market to an existing multi-market pack, please ensure that you create **a new version of the PMD** and include all relevant target

### Deployment of the NMVS release 16 and downtime in the Finnish NMVS production environment on Wednesday, May 21st, 2025

There is a downtime window in the production environment of the Finnish NMVS due to the deployment of the NMVS release 16 starting at 23:00 EET on Wednesday, May 21st and ending at 05:00 EET on May 22nd at the latest.

As a result, end users may not be able to verify packs in real-time and OBPs may not be able to upload data in FiMVS.

## Nordic recommendations on the use of status 'Locked' in the EMVS

The functionality to mark a pack as locked can provide added value and security in preventing medicines in quarantine or under investigation entering in or going back into the supply chain.

The functionality is not a legal requirement and the use of it is voluntary.

The Nordic medicines verification organisations have published a Best Practice Guide for using this feature in the system.
